

Harvard kicks off l fundraising effort

\$6.5 billion campaign to bolster key priorities

H

arvard University publicly kicked off a \$6.5 billion fundraising campaign today, an effort that, if successful, would be the largest ever in higher education.

Harvard today emerged from what fundraisers call the campaign's "quiet phase," during which the institution raises a portion of the total before the public launch. Harvard already has raised about \$2.8 billion in gifts and pledges, leaving a target of about \$3.7 billion.

The University's endowment stood at \$30.7 billion last year, but Faust cautioned recently against thinking of the endowment as a "checking account" that can be drawn down at will. The endowment is a linked pool of thousands of funds, most of them dedicated to specific purposes — such as named chairs or individual institutes or programs — that must be managed into perpetuity, a feature that limits the funds that can be withdrawn in any given year to about 5 percent.

Chulalongkorn University is Thailand 's oldest university and for many decades now has been graduating students who have played important roles in the country's development. The Chula Alumni Association has thus become an important organization in promoting and assisting all Chulalongkorn students, past and present. The Alumni Association is also committed to aiding Thai society and so organizes a number of activities, for example, to raise scholarship funds as well as promote education.

Popularly known as Chula, the University has 20,000 students preparing for Bachelor, Master and Doctorate degrees, and 2,500 full-time faculty members. Chula receives 60% of its funding from government, 30% from property management and the remainder from academic fees.

Universities resort to cold calling exstudents

Nine million graduates asked for cash donations as institutions adopt aggressive US-style tactics

Universities targeted more than nine million of their former students with cold calls and spam emails over the past year as they increasingly adopt US-style tactics to raise funds.

Philanthropic donations to institutions are at a record high but the growth in aggressive fundraising has angered graduates of wealthy universities who are still struggling to pay back huge levels of student debt.

The number of graduates asked to donate has nearly doubled in the past decade with almost 9.3 million approached last year and 174,000 (1.4 per cent) making a gift, according to the latest annual report from the Ross Group and the Council for Advancement and Support of Education.

Universities now spend £80m a year on fundraising – up from £34m in 2005 – and secured £660m in cash donations in 2012-13, with older graduates who received a free education much more likely to contribute.

The BFR methodology refers to eight steps of transformation, which are: ☐ Strategic direction in determining the transformation goal from the onset and time period; ☐ Lab sessions for intense problem-solving, rigorous analysis and stakeholder engagements; ☐ Sharing of lab session findings with employees of the organisations in a town hall setting; ☐ Publishing the roadmap with the public to establish commitment and delivery; Outlining key performance indicators (KPIs); ☐ Implementation of the agenda;

☐ Inviting a panel of international experts to conduct panel review and audit; and, Providing an update on the progress of the transformation pro-

gramme to all stakeholders, typical-

ly through an annual report.

"I always look at transformation work coming on two waves of activities. The first involves the intervention work required to the deliver BFR. This is the intervention wave," said Idris during his keynote address at the Global Transformation Forum (GTF2015), here, yesterday.

SEKARANG: Hanya membelanjakan wang peruntukan daripada kerajaan sepenuhnya tanpa menambah nilai dana.

APA YANG PERLU DIBUAT?

- Menggunakan wang peruntukan, dana sumbangan dan sebagainya di dalam pelaburan yang menguntungkan.
- Contoh pelaburan yang mudah ialah memasukkan wang untuk simpanan tetap (*fixed deposit*) di dalam bank yang memberikan kadar faedah paling tinggi.

MENGURUSKAN DANA BAGI MENGURANGKAN PEMBAZIRAN DAN MENJIMATKAN

SAMBUNGAN..

Universiti perlu membuat pelaburan dalam syarikat pelaburan yang memberi pulangan tinggi serta berisiko rendah. Contohnya Public Mutual, KWSP, PNB

- Melantik pakar pelaburan (Investment Manager) bagi mengurus dana untuk pelaburan dan penjanaan kekayaan.
 - Ganjaran dibayar mengikut keuntungan yang diperoleh

MENGURANGKAN PEMBAZIRAN

- Kontrak diberi mengikut tender dengan harga yang termurah. UMS telah kurangkan perbelanjaan sebanyak RM1.2 juta setahun dengan menukar kontraktor.
- Mengurangkan kakitangan, menambah efisiensi
- Menambahbaik kemampuan bekerja dan cara melaksanakan suatu tugas

MENGURANGKAN PEMBAZIRAN

- Menghapuskan rasuah kerana kakitangan yang makan rasuah merugikan majikan: Contohnya rumput tak dipotong, longkang tak dibersihkan.
- Elakkan pembaziran air, elektrik dan mengurangkan bil telefon.
- Penyelenggaraan peralatan pejabat dan bangunan termasuk asrama. Pelajar / pengetua mesti bertanggungjawab (Di China, setiap pelajar menutup meja mereka dengan kain.
